If you feel that you are vulnerable to COVID-19 we urge you to stay home Float or car must be decorated in colors and style befitting the spirit of Independence Day All units with a generator must carry a 5 lb. ABC 2A-10B, C fire extinguisher and must have annual stamp or be certified from extinguisher company. All units should have a sign or banner indicating who they represent (* See #13 also) The firing of black powder is allowed The use of water balloons and high-powered water cannons is prohibited No candy or any other food items may be thrown or distributed this year due to COVID concerns. We hope to allow this at the Christmas Parade. All units must be motorized or peddled. No marching, walking, or equine units can be accommodated No person or organization may charge a fee or request a donation to be on any float or to participate As a Non-Profit 501(c)(3) organization, we cannot allow any activities related to political advertising, solicitation, campaigning, or endorsements All entries into the parade must be approved by the Anna Maria Island Privateers no exceptions lure to abide by these rules could result in expulsion from the parade and possibility being banned from future Anna Maria Island Privateers Parades
