Please read the following articles of participation.

1. The parade leaves **COQUINA BEACH** in **BRADENTON BEACH** at 10:00am. It will proceed through the 3 island cities, ending at **BAY FRONT PARK** in **CITY of ANNA MARIA**.
2. All floats and units must be staged by **9:30 AM**.
3. You must be pre-registered or turn in an application in staging. Entry is free, but donations are accepted and greatly appreciated. A portion of donations received will go to the Early Learning Coalition of Manatee County
4. A Release Form must be submitted by each entry
5. We do not have a mask requirement at the parade. If you feel that you are vulnerable to COVID-19 we urge you to stay home
6. Float or car must be decorated in colors and style befitting the spirit of Independence Day
7. All units with a generator must carry a 5 lb. ABC 2A-10B, C fire extinguisher and must have annual stamp or be certified from extinguisher company.
8. All units should have a sign or banner indicating who they represent (* See #13 also)
9. The firing of black powder is allowed
10. The use of water balloons and high-powered water cannons is prohibited
11. No candy or any other food items may be thrown or distributed this year due to COVID concerns. We hope to allow this at the Christmas Parade.
12. All units must be motorized or peddled. No marching, walking, or equine units can be accommodated
13. No person or organization may charge a fee or request a donation to be on any float or to participate
14. As a Non-Profit 501(c)(3) organization, we cannot allow any activities related to political advertising, solicitation, campaigning, or endorsements
15. All entries into the parade must be approved by the Anna Maria Island Privateers no exceptions

Failure to abide by these rules could result in expulsion from the parade and possibility being banned from future Anna Maria Island Privateers Parades

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM
